

L-G nod to appoint son of cop killed on duty

THE SON OF ASI Shambhu Dayal Meena, who was stabbed to death while apprehending a snatcher in West Delhi last month, will be appointed as a sub-inspector in the Delhi Police after L-G VK Saxena's intervention.

In recognition of his father's exemplary courage and valour in the line of duty, Saxena invoked his special powers in Deepak Meena's appointment in the Delhi Police after L-G VK Saxena's intervention. The victims have been identified as Vansh Sharma (23), a B.Tech student from a private college, and Monu (20), a BA student from Delhi University's School of Open Learning.

The incident took place near Kranti Nagar flyover railway lines. According to police, the duo were making videos in the afternoon when the train ran over them.

A PCR call was made in the evening and their bodies were found by railway police personnel and sent to a hospital. Their phones have also been recovered from the spot.

DCP (Railways) Hareesh HP said, "The deceased were identified as Vansh and his friend Monu alias Varun. Vansh was pursuing B.Tech and was in his third year while Monu also worked as a salesman. An enquiry was conducted and it was found that the deceased would often come to railway tracks and shoot reels and videos. Inquest proceedings have been initiated. There is no evidence of foul play so far."

# Shooting Insta reels on railway tracks, 2 run over by train

RECORDING INSTAGRAM reels and videos on the railway tracks took a fatal turn for two college students who were run over by a train in Shahdara Wednesday.

The victims have been identified as Vansh Sharma (23), a B.Tech student from a private college, and Monu (20), a BA student from Delhi University's School of Open Learning.

The incident took place near Kranti Nagar flyover railway lines. According to police, the duo were making videos in the afternoon when the train ran over them.

A PCR call was made in the evening and their bodies were found by railway police personnel and sent to a hospital. Their phones have also been recovered from the spot.

DCP (Railways) Hareesh HP said, "The deceased were identified as Vansh and his friend Monu alias Varun. Vansh was pursuing B.Tech and was in his third year while Monu also worked as a salesman. An enquiry was conducted and it was found that the deceased would often come to railway tracks and shoot reels and videos. Inquest proceedings have been initiated. There is no evidence of foul play so far."

Investigation revealed that Vansh had two profiles on

Instagram where he claimed to be a "creator and a politician". Monu also had two social media accounts.

According to police, they posted reels around the railway tracks which featured them jumping from the train and running around tracks while trains were passing. Police said they would also enact movie scenes and dialogues for their videos. Monu also uploaded reels where of him riding bikes and dancing. Vansh is survived by his parents and younger brother. While they refused to comment on the case, they said he wasn't associated with any political party.

Monu's family lives right opposite Vansh's house and they said the two knew each other since they were teenagers.

Monu's elder brother, Sonu, who works at an electronic store,

said, "My mother was the last person to see him... He had asked her to cook rajma-chawal. We knew he liked making videos and reels but we didn't expect this to happen. He wasn't reckless. We think he died trying to save Vansh as he got stuck on the track. Vansh's phone was also completely damaged, Monu's was found lying on the side and wasn't damaged."

The family said Monu had started working as a salesman to support the family. "He loved travelling and riding his bike. He would roam for hours. How could this happen? He didn't have any earphones or headphones on. We want an enquiry in the case," alleged Sonu.

Police said they are looking into the family's allegations and checking CCTV cameras along the tracks.

# Construction of Gurugram Metro project will begin in 2023-24, says CM Khattar

HARYANA CHIEF Minister Manohar Lal Khattar, while presenting the Haryana Budget 2023-24 in the State Assembly Thursday, said construction work of the Gurugram Metro project will commence in 2023-24.

"...the long-pending Gurugram Metro project has been approved by the Public Investment Board in the central government and final approval of the Union Cabinet is awaited.

I hope that construction work of the Gurugram Metro will commence in 2023-24," said Khattar.

He added that he had proposed that work on three other metro links — from Rezagla Chowk to Indira Gandhi International Airport in Delhi; from Southern Peripheral Road to Panchgaon via Global City and Manesar; and extension of the Bahadurgarh Metro up to Asaudha to connect with the Haryana Orbital Rail Network and Kundli-Manesar-Palwal (KMP) expressway — is taken up in 2023-2024.

The proposed 28.8-km-long corridor, known as "Gurugram Metro" project, from Huda City Centre to Cyber City via Old Elevated stations, including a spur to the Dwarka expressway.

As per the project's detailed project report, the stations on the route are Huda City Centre, sector 45, Cyber Park, sector 47, Subhash Chowk, sector 48, 72 A, Hero Honda chowk, Udyog Vihar 6, sector 10, 37, Basai, sector 9, 7, 4, and 5, Ashok Vihar, sector 3, Bajghera road, Palam Vihar Extension, Palam Vihar, sector 23

A, 22, Udyog Vihar 4, Udyog Vihar 5 and Cyber City. The project is proposed to have an interchange with Rapid Metro and the proposed metro extension project connecting Palam Vihar in Gurgaon to Dwarka sector 21 in Delhi at Rezagla chowk.

Officials had said last year that the proposed metro extension connecting Palam Vihar and Dwarka sector 21 stations will be 8.4 km long, out of which 4.9 km will be from Palam Vihar to sector 111 in Gurgaon, and 3.5 km from sector 111 to Dwarka sector 21 in Delhi.
